

Management's Responsibility for the Financial Statements

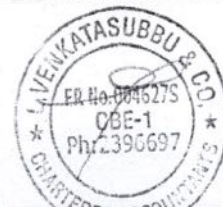

Opinion

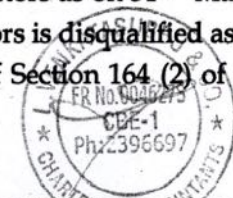

Meaning of Internal Financial Controls over Financial Reporting

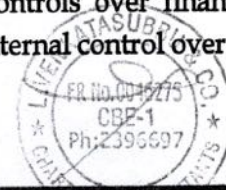
